CATERING, CLEANING AND ASSOCIATED SERVICES**

Santos NA (19-12) Pty Ltd (Santos) is the operator of the Bayu-Undan Facility, located in Timor-Leste offshore waters.

Santos is currently assessing support services requirements for the remaining period of production and Suspension of Operations activities following Bayu-Undan cessation of production.

Recognising that the Bayu-Undan scope of work will be carried out under exclusive Timor-Leste jurisdiction, Santos wishes to identify opportunities for activities to be conducted out of Timor-Leste either through direct local participation or through participation of Timor-Leste companies through partnership or alliance models.

Santos is now seeking expressions of interest from companies who are a duly incorporated entity under the laws of República Democrática de Timor-Leste and who are:

- capable of directly providing the referenced goods or services to the Oil and Gas Industry and meet the minimum requirements listed; or
- in partnership or alliance with other entities that are capable of providing the referenced goods or services, and who meet the minimum requirements listed.

Santos notes that the Bayu-Undan Suspension of Operations Project is still in the assessment phase, and this Advertisement does not bind any party to proceed with further contracting activities in respect of any of the work scopes detailed below.

Description

Catering and Cleaning

Scope includes:

- Provision of catering, cleaning, laundry services (personal and general), rubbish coordination and pest suppression at Bayu-Undan facility.

Minimum Requirements:

- Provide sufficient personnel and goods to meet all catering and cleaning, consistent with Australian offshore catering standards, for all personnel working on the Bayu-Undan Facility. Total POB (Personnel on Board) will range from a minimum of 40 to a maximum of 188. Overall POB is limited to 104 on the CUQ and 84 on the FSO including catering staff. This number will vary over the course of the project and will reduce in the final months of the project.
- Provide sufficient catering personnel to cover Bayu-Undan personnel operating 24hrs/day 7 days/week.
- Offshore catering personnel to include but not be limited to Camp Supervisor, Head Chef, Senior Chefs, Kitchen Staff, and Cleaners.
- Establish onshore team to support the offshore catering personnel logistics.

- Supply of all catering equipment (excluding what is currently offshore) for the Bayu-Undan facilities.
- Specify and provide all food provisions to effectively sustain personnel on Bayu-Undan.

Companies who meet, or who are partnered or in alliance with companies who meet, all of the minimum requirements listed are invited to submit their written expression of interest by email or hand delivery no later than **Friday, 19 July 2024** for the attention of Rulison Almeida de Jesus, Purchasing and Supply Officer.

When submitting written expressions of interest, Santos kindly requests that companies clearly reference the title of the scope(s) they wish to register interest in. Furthermore, submissions should also be supported with high-level information or a summary of experience, which demonstrates compliance with the minimum requirements contained within this expression of interest.
